The Duty Judge shall be assisted by his/her own staff and shall inform their own court staff to remain present by that particular time.

- The Duty Judge to call only those staff who are residing in Delhi and are using their own 10. conveyance.
- It is further ordered that all the Judicial Officers posted in North-West District shall not 11. leave the station under any circumstances and they shall always be available on call and would be decreased may call and would be deemed to be on duty. In case any urgency, the undersigned may call upon them to report back for duty immediately.
- Lawyers/Litigants are requested to use Video-Conferencing for addressing the arguments 12. so that overcrowding is avoided and social distancing is also maintained.
