
ORDER

Pursuant to the directions contained in order dated 14.05.2020 passed in W.P. (Cr.) 804/2020 titled as Hansraj & Ors. Vs State of Delhi & Ors. by Hon'ble High Court of Delhi and in continuation of order no. D&SJ(N&N-W)/Sectt./RC/2020/14475-14560 dated 21st April 2020 issued by the undersigned(s), all the Duty Judge(s) and concerned(s) are further directed that :-

1. In bail matters, Duty Judge(s), while deciding the urgency of matter, will not insist for filing of the signed/attested vakalatnama, signed and attested affidavits or applications where the applicant is in jail and/or of the family members of such an applicant, reside outside Delhi.
2. If the petitioner/applicant/plaintiff resides outside Delhi and if signed/attested vakalatnama is not appended with any urgent matter then the Branch Incharge, Filing Section, Rohini Courts shall seek an email from any of the siblings/close relative of the petitioner/ applicant / plaintiff affirming the appointment of counsel and also seek an undertaking to sign the vakalatnama and other original documents within two weeks of the lifting of the lockdown. Aadhaar number and phone/mobile number of the sibling/close relative be also mentioned in such email/authority letter.
3. Physically signed and attested Vakalatnama of a petitioner/applicant/plaintiff, who is in custody or not residing in Delhi will not be insisted upon while deciding the urgency of matter.

The above directions shall be complied with in letter and spirit by all the concerned(s).




