CIRCULAR

Pursuant to the directions of Hon'ble eCommittee, Supreme Court of India and Hon'ble I.T. Committee, High Court of Delhi, all Judicial Officers are again requested to download, install and use Government Instant Messaging System (GIMS) Application (App) developed by National Informatics Centre (NIC) for sharing official communications quickly.

1. GIMS App is available for both Android and Apple iOS users. GIMS App is equivalent to other instant messaging applications such as WhatsApp, Telegram and is a **Made in India** App. The servers of GIMS App are situated in India and maintained by NIC.
2. GIMS App permits the users to not only send text messages, audio messages, make voice and video calls, share images, documents peer to peer but also in a Group with end to end encryption.
3. The Apple iOS users can download the GIMS App Ver. 2.0 from the Apple App store. The Android users can download the GIMS APP from <https://www.gims.gov.in> by signing-in through either of the two modes provided on the website. A user can log-in/sign-in by using their email addresses for e.g. xxx@AIJ.GOV.IN or xxx@NIC.IN or mobile phone number and password/OTP by visiting the webpage <https://www.gims.gov.in>
4. Sh. Hargurvarinder Singh Jaggi, (DHJS), ADJ-02, Officer In-charge (Computers), South West District, Dwarka Courts Complex and Sh. Robinjeet Singh, (DJS), Judge-Virtual Court have been appointed as the Nodal Officers (GIMS) by the Hon'ble I.T. Committee, High Court of Delhi for managing members, groups and monitoring the organisation unit of GIMS App for Delhi Judiciary.
5. The Officers In-Charge, Computers of all district/courts complexes may contact Sh. Hargurvarinder Singh Jaggi, (DHJS) for any help, assistance for the purpose of addition, deletion, modification and taking onboard all the Judicial Officers, who have not yet been taken onboard for whatsoever reasons.
