
In this regard, it is mentioned that still the order dated 04.09.2019 of the Hon'ble High Court has not been uploaded on the website of the Hon'ble High Court.


Office has informed that necessary action in terms of minutes dated 06.09.2019 have already been taken. Let a follow up be taken by the office accordingly.


In respect of the announcement of election schedule, the Hon'ble Members sincerely feel that the announcement of election schedule should not be done by the committee unless a communication from the Hon'ble High Court or the order of the Hon'ble High Court dated 04.09.2019 is made available to the committee. Office has communicated with Ld. Registrar General, Hon'ble High Court of Delhi telephonically on more than one occasion. It has been brought to the notice of the committee that as per information received the order is still not uploaded on the website. The decision on the aforesaid issue is accordingly deferred today.

In so far as, the verification of electoral rolls are concerned, after discussion the committee is of the unanimous view that the issue be also taken up on 11.09.2019 by which time the order of Hon'ble High court shall also be expected to be available.
