"The matters which have already been heard and the orders/ judgments are yet to be passed by the Trial Courts, the learned Courts are always at liberty to deliver such orders/ judgments. There is no reason with the Trial Courts not to pass the orders/ judgments in the cases in which both the parties have already been heard by the learned Trial Courts."

- c) No. of matters wherein reserved Judgment/Order have been pronounced with effect from 25.03.2020 to till date.

Furthermore, as mandated vide the above referred order, all the Ld. Judicial Officers posted in North-West District, Rohini Courts, Delhi are requested to pronounce the reserved Judgments/orders at the earliest.
