



Rest of the order shall remain unchanged.





**Note:-**

- (1) The Judicial Officers shall ensure that on the day when they hold physical court, the cause list of their respective court shall be session-wise, in sense that it shall specify which cases shall be taken up in 1<sup>st</sup> session (from 10:30 a.m. to 12:30 p.m.) and which cases shall be taken up in 2<sup>nd</sup> session (from 02:00 p.m. to 03:30 p.m.).
- (2) On the days other than the above mentioned physical courts days, every Judicial Officer shall hold court through Video Conferencing, taking up the entire cause list of that day her/his court.
- (3) All concerned shall ensure adherence to the **standard operating protocol (SOP)** dated 19.08.2020, and maintain social distancing while holding courts physically, as already circulated amongst the Judicial Officers, Staff as well as the Bar.
- (4) The Judicial Officer of vacant court of Ld. ADJ-04 shall hold his/her court physically and virtually as & when posted for the period mentioned against his/her name.
- (5) The Digital Courts (NI Act) shall continue functioning through virtual mode as per the order no. 70/DHC/Gaz/G-7VI.E.2(a)/2020 dated 02.11.2020 of Hon'ble High Court of Delhi, New Delhi.
- (6) The Judicial Officers are also permitted to record evidence (except in those cases where the accused is in custody)
