#### Sub: Advisory for self isolation/home quarantine.

Sh. He is also directed to inform this office regarding his health status after the expiry of 14 days.

As a preventive measures, other officials posted in the Court of Sh. Virender Singh, Ld. ACJ/CCJ/ARC, North District, Rohini Courts, Delhi who came in close contact with Sh. Amit Kumar on 27.04.2021 are advised to self monitor their health for the next 07 days or as per the medical advice and take all necessary precautions as per the advisory/ guidelines issued by Government of India. They are further advised to intimate this office, if they found any symptoms of Covid-19.
