# Sub: Advisory for self isolation/home quarantine.

It has been brought to the notice of the office that mother of **Sh. Suresh Joshi**, JA in the Accounts Branch, North District, Rohini Courts, Delhi has been tested positive for Covid-19 contagion on 27.04.2021. It is informed by the official that he has visited hospital and Covid Testing Center with her mother three or four times for her medical check-up and Covid test, who has been tested positive for Covid-19 on 27.04.2021. It is also informed by the official that he has taken his mother to the doctor and testing center on his scooter and came in close contact with her. The official had lastly attended the court on 22.04.2021

Considering this situation, Caretaking Branch is directed to carry out deep cleaning and regular sanitization in the Accounts Branch (North).

Considering the fact that the official came in close contact with Covid-19 patient. Hence, he is advised to home quarantine himself immediately for a period of 07 days **w.e.f. 27.04.2021 to 03.05.2021** or as per the medical advice and take all necessary precautions as per advisory/guidelines of Government of India. He is directed to inform this office regarding his health status after the expiry of 07 days.
