STANDARD OPERATING PROTOCOL

In continuation of all earlier orders, the following additional directions are being issued with immediate effect from 22nd April 2021 to 24th April 2021 :-

1. Judicial Officers will take up the urgent matters, if any, only through Video Conferencing and all the cases other than urgent matters shall be adjourned enbloc and the KHARJA/entries of the same on CIS shall be done by the concerned court staff.
2. Lawyers/litigants may note the next date of hearing, as reflected in the cause list of the day itself and the cause list can be accessed from the e-courts websites and e-courts mobile app.
3. All the bail applications (For Sessions Courts) shall be filed on the below email(s) which are exclusively for filing of Bail Applications:-

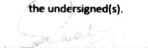

4. All the bail applications/other applications/correspondences viz. Superdari, Jamatalashi, Traffic Challan of impounded vehicle, Status Reports etc. which pertain to the establishment of Chief Metropolitan Magistrate shall be sent directly to the Email Id of the concerned court. List of Email IDs of the courts is attached herewith.
5. Ld. Metropolitan Magistrate will ensure that the bail applications / other applications/correspondences viz. Superdari, Jamatalashi, Traffic Challan of impounded vehicle, Status Reports etc. filed by any Lawyer/Litigant on the Email ID of the respective court be given a registration number by their own staff so that the movement of the same is recorded and the case can be identified.
6. Ld. Metropolitan Magistrates will also direct IO/SHO concerned to keep copies of such orders after downloading from website of North & North-West District, Rohini Courts and the order be filed alongwith chargesheet.

7. Dasti Copy of the orders, if directed by Ld. Judicial Officers then the Reader / Ahlmad/Asstt. Ahlmad of the concerned court shall send digitally signed copy of the same to the Lawyer/Litigant and the same will be treated as Dasti Copy.
8. Copies of the Orders/Judicial Proceedings (as per law) in bail applications/other applications/correspondences viz. Superdari, Jamatalashi, Traffic Challan of impounded vehicle, Status Reports etc. which pertain to the establishment of Chief Metropolitan Magistrate shall be sent by the concerned staff/official on duty on that particular day to all the concerned stakeholders and soft copies of the orders/judicial proceedings passed on a particular day shall be sent to the Branch Incharge, Computer Branch, Rohini Courts for uploading the same on website preferably on the same day.
9. The Branch Incharge, Computer Branch shall create a separate icon/tag viz. **"ORDERS PASSED W.E.F 22ND APRIL 2021 TO 24TH APRIL 2021"** and upload all the orders/judicial proceedings on the website under this icon / tag for easy accessibility to the Litigants and Lawyers.
10. Bail application(s) filed through Delhi Legal Services Authority shall also be filed in soft form on the email IDs of the concerned court. Necessary steps be taken at the end of Secy. (DLSA) (North & North-West), Rohini Courts.
11. The cases/applications filed in the Filing Branch, Rohini Courts in physical form be opened by Branch Incharge, Filing Section, Rohini Courts after expiry of 3 days and the files shall be then registered as per law and placed before the Concerned Authority for their assignment/markings.
12. All the complaints of 138 NI Act shall continue to be filed through e-filing portal only.
13. The Ministerial Staff/Official on Duty on that particular day of the courts (except the courts of Chief Metropolitan Magistrate Establishment) are responsible for uploading the daily orders/judicial proceedings of the particular day on CIS.
14. Lawyer/Litigant are advised to check the website of North & North-West District daily to get the update/progress of their case as well as any other directions passed periodically by the undersigned(s).

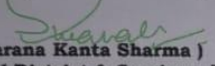
CIRCULAR

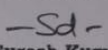

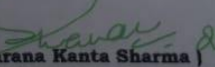

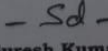
