Hon'ble the Chief Justice has been pleased to make the following posting/transfer in the Delhi Higher Judicial Service with immediate effect :-

Notes :

1. The Judicial Officer shall be under the control of the District & Sessions Judge of the District to which they have been allocated.
2. The court of Addl. District Judge-2, Shahdara hitherto presided over by Mr. Ajay Gupta stands abolished and the District & Sessions Judge, Shahdara shall transfer all the cases pending in his court and assign the same to the court of Mr. A.S. Jayachandra.
3. The District & Sessions Judge, Shahdara shall transfer all the cases (other than POCSO and NDPS cases) pending in the Court of Mr. T.S. Kashyap, ASJ-1 + Special Judge (NDPS), Shahdara and assign the same to the newly created Court of Mr. Ajay Gupta, ASJ-4.
4. The court of Addl. District Judge-1, Shahdara hitherto presided over by Mr. A. S. Jayachandra stands re-designated as Addl. District Judge, Shahdara.
5. The court of Addl. Sessions Judge, Shahdara hitherto presided over by Mr. Pulastya Pramachala stands re-designated as Addl. Sessions Judge-3, Shahdara.
6. The Court of ADJ-1, North-West, Rohini hitherto presided over by Sh. Manish Gupta stands redesignated as ADJ-1 + MACT, North-West, Rohini. The District & Sessions Judge, North-West, Rohini shall assign sufficient number of MACT cases to the Court of Sh. Manish Gupta on withdrawal from the Court of Ms. Barkha Gupta, PO, MACT, North-West.
