- The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- The courts of ADJ-04, East, KKD and ADJ-03, Shahdara, KKD are abolished. The District & Sessions Judges of the concerned districts shall allocate the cases of the said abolished courts to other such courts so as to ensure equal pendency.
- In the districts where the pendency of cases relating to commercial disputes under the Commercial Courts Act, 2015 is high, the District & Sessions Judge shall allocate manageable workload of such cases to the court of District Judge (Commercial Ccurt). considering that more such courts may be established in the near future. However, where the pendency of such cases is comparatively low in the court of District Judge (Commercial Court), the District & Sessions Judge may additionally allocate civil work to such Court and when adjudicating such cases, the District Judge (Commercial Court) shall
