
" The Hon'ble Administrative and General Supervision Committee of this Court while considering further extension of suspended functioning of this Court and the Courts Subordinate to this Court and taking note of the prevalent situation, in continuation of this Court's Office orders No.373/Estt./E1/DHC dated 23.03.2020, No.159/RG/DHC/2020 dated 25.03.2020 and No.R77/RG/DHC/2020 dated 15.04.2020, No.R-159/RG/DHC/2020 dated 02.05.2020, No.R235/RG/DHC/2020 dated 16.05.2020, R-305 /RG/DHC/2020 dated 21.05.2020 and No.1347/DHC/2020 dated 29.05.2020 has been pleased to order that the functioning of the Courts subordinate to Delhi High Court shall continue to remain suspended till 30.06.2020.

It is further ordered that the matters listed in the courts subordinate to Delhi High Court on 15.06.2020 be adjourned en bloc in terms of the earlier directions."
