Sir,

This is for your kind information that, the *Deputy Commissioner (Now Divisional Commissioner) of Delhi, has been notified as competent as well as inspecting authority under the Notaries Rules, 1956 for notaries, as per the Notification No. F. 10(2)/56-Judl. 1 dated 28 March, 1956 (Copy enclosed)*, and consequent upon the recommendation of Competent Authority as per rule 7 of Notaries Rules, 1956, Law department notifies the names of recommended applicants as Notary in the Official Gazette of Delhi after comply with due procedure as prescribed by law.

In this context, this is brought to your kind notice that as per sub-rule 1 of rule 4 of the Notaries Rules, 1956, the applications of Advocates for the appointment as fresh Notary is required to be forwarded through the concerned District Judge or the Presiding Officer of the Court or Tribunal where he practices as an Advocate to the "Competent Authority". However applications of Advocates are usually been forwarded to this Office instead of forwarding the same to Competent Authority under the aforesaid rules.

In view of the above, it is requested that, the applications for the appointment as Notary may directly be sent to the "Competent Authority" notified under the Notaries Rules, 1956 i.e. Divisional Commissioner, Revenue Department, GNCTD, so that the process of appointment of fresh Notaries could be initiated without any further delay in paper work.
