The criteria for allotment of chambers to the Bar members in terms of the notification dated 31.08.2018 is fixed as under:-

- The applicant advocate must be enrolled with the Bar Council of Delhi and must be a member of Rohini District Courts Bar Association (which came into existence with effect from 21.09.2006 after being formed under the directions of the High Court of Delhi after holding elections under the supervision of Bar Council of Delhi) on the date of submission of application for allotment of chamber.
- The applicant advocate must be primarily practicing at the Rohini Court Complex for at least 3 years before the date of advertisement. For such purpose number of vakalatnamas and appearances may be relied upon, as disclosed by the applicants. The advocate should be permanent resident of National Capital Territory of Delhi. However, there is no mandatory requirement of filing of 10 Vakalatnamas and 50 appearances.
