

Applications on the prescribed format are invited from eligible candidates i.e. members of the Bar (Advocates) belonging to General Category, Scheduled Caste Category and OBC category for appointment as Additional District and Sessions Judges in H.P. Judicial Service in the cadre of District Judges / Additional District Judges in the pay scale of ₹51550-63070 for the following vacancies:-
