The RCBA Election Committee 2017 has held its Seventh meeting on Wednesday, the 22nd day of February 2017.

The Committee has preliminarily scrutinized the Registers and some of the files of Declaration Forms and on cursory scrutiny, it has been seen that in the Register, Declaration Forms from 3579 to 3601 were issued but not deposited by the members with RCBA. There is an entry to this effect in red ink under the signature of the President of RCBA showing that no such forms were deposited. There are no signatures of such members in the Register. 
3588, 3589, 3587, 3586, 3585, 3582, 3596, 3581 & 3580 have been found in file no.19. It cannot be ruled out that other files may also contain such forms. This is a serious matter and it appears that after closing of the Register of Declaration on 15.02.2017, Declaration Forms have been accepted at office of RCBA.

3. The Committee perceives this as totally wrong, unethical and a question mark on the sanctity of deposit of Declaration Form.


4. It has been unanimously resolved that a letter be written to RCBA calling for explanation on this aspect to be replied within 24 hours.
