Copy of Minutes of Meeting of Hon'ble State Court Management System Committee held on 04.02.2020 in this regard, has already been sent to all the concerned courts i.e. Courts of District Judge (Commercial Court) & all the courts of Additional District Judges (North & North-West District) by the concerned Judicial Branch for information and compliance.
