



CIRCULAR


Subject : Regarding matters of "Commercial Dispute" as defined in Section 2(1)(c) of the Commercial Courts Act, 2015.

In continuation of earlier circular no. D&SJ(N/W & North)/Sectt./RC/2020/2448-2470 dated 24.01.2020 of the undersigned (s) and pursuant to the directions contained in the Minutes of Meeting of Hon'ble State Court Management System Committee held on 04.02.2020 in this regard, it is informed to all the Judicial Officers posted in North & North-West District, Rohini Court Complex, Delhi that those civil suits even if commercial in nature instituted prior to 03.05.2018 would not be governed by the Commercial Courts Act, 2015 (as amended on 03.05.2018). Only those cases instituted on or after 03.05.2018, which fall within the definition of "Commercial Dispute" as defined in Section 2(1)(c) of the Commercial Courts Act, 2015, shall be entertained by the Courts of District Judge (Commercial Court). Copy of Minutes of Meeting of Hon'ble State Court Management System Committee held on 04.02.2020 in this regard, has already been sent to all the concerned courts i.e. Courts of District Judge (Commercial Court) & all the courts of Additional District Judges (North & North-West District) by the concerned Judicial Branch for information and compliance.

Concerned Judicial Officers are requested to comply with the aforesaid directions.




