CIRCULAR

Vide order dated 29.11.2018 in Crl. M.C. 6030/2018 & Crl. M.A. 48326/2018 titled "Smt. State of NCT of Delhi Vs. Ram Niwas", Hon'ble Mr. Justice R.K. Gauba has passed the following directions:-

It is also noted that the criminal revision no. 11/2018 was heard and decided by Mr. Narinder Kumar, an officer of Delhi Higher Judicial Service who is presently posted as Special Judge, NDPS at Central District, Tis Hazari courts Delhi. It appears that aside from the cases involving offences under NDPS Act, he is also dealing with matters pertaining to the jurisdiction of a sessions court. As has been noticed, only few days back, the judicial officers exercising the power and jurisdiction of the sessions court do not properly indicate the jurisdiction under which they are functional while dealing with such matters as bail applications or revision petitions, and instead describe themselves with reference to the status under the special law which may have been allocated to them for the time being. In the impugned order dated 15.01.2018, the judicial officer has described himself as Special Judge, NDPS. While dealing with the revision petition, he was not exercising the powers of Special Judge NDPS. Instructions have been directed to be issued in the past to all concerned for the appropriate jurisdiction to be reflected in the court proceedings.
