The fake appointment letters are also seen to be unauthorisedly using forged official seal of Court to mislead public.

The public in general and the persons who received such fake appointment letters, in particular, are hereby advised to kindly cross-check and verify the facts of any recruitment from the authenticated sources before and also to verify the identity/ authenticity of individuals/recruitment-agencies who issue such appointment letters, before responding.
