CIRCULAR

It has come to notice of the undersigned(s) and other Judicial Officers posted in Rohini Courts, Delhi that some mischievous elements of the society are issuing fake appointment letters for issued post of subordinate officials.

In this regard, it is hereby informed to public at large that recruitment of all categories of subordinate officials of Delhi District Court's establishment is exclusively within the domain of Ld. Principal District & Sessions Judge (HQs), Tis Hazari Courts, Delhi ONLY. No other private agency or any other District Court's establishment in Delhi has been authorized to do the same. Any appointment letter purportedly issued by any other authority is fake and illegal as recruitment of subordinate officials of all categories of subordinate employees in Delhi's District Courts establishment are filled up by giving wide publicity through Employment Notifications published on the official website and in newspapers. The fake appointment letters are also seen to be unauthorisedly using forged official seal of Court to mislead public.

The public in general and the persons who received such fake appointment letters, in particular, are hereby advised to kindly cross-check and verify the facts of any recruitment from the authenticated sources before and also to verify the identity/ authenticity of individuals/recruitment agencies who issue such appointment letters, before responding.


