The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion.</p> <p>Note 2. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall not ordinarily exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years on the closing date of receipt of application.</p>

2. The Pay of the officer selected will be governed in accordance with DOP&T O.M No 6/8/2009-Estt (Pay II) dated 17.06.2010, as amended from time to time.

3. It may please be noted that :-

- (a) Applications received after the last date will not entertained.
- (b) Applications will have to be routed through their parent departments.
