CIRCULAR

It has been noticed that the staff officials are not taking care of computer hardware like Computer Systems, Printers, Additional TFTs, UPSs, VGA Cable, Splitters, Mouse, Keyboard etc provided to them by the office, as frequent complaints are being received regarding physical damage to such hardware like cuts of wires and breakage of computer hardware/items.

The computer hardware/items are very sophisticated and require utmost care in use and handling to keep them in proper working condition, thus all staff officials are directed to ensure proper cleanliness in the court rooms/branches. Since physically damaged hardware is not covered under guarantee/warranty/ annual maintenance contract, hence becomes use-less and causing financial burden on repair.

In view of the above, all staff officials are directed to take care of all computer hardware issued in their name and provided in the court/branch and prevent damage thereto. Henceforth, any damage to the computer hardware shall not be tolerated and the user/custodian officials would be liable for strict disciplinary action and recovery of cost on repair from them.
