**2.** Every Presiding Officer of the Evening Courts will be assisted by his/her own staff consisting of Reader, One P.A./Sr. P.A. and one orderly.

**3.** Whenever any Judicial Officer is on leave or busy in Administrative work or is not available due to any reason, his/her work shall be looked after by the link judicial officer shown immediately below him/her in the above table. In case both the said judicial officers are on leave or not available due to similar reason, the judicial officer whose name is mentioned immediately below next in the table shall work as next link judicial officer and so on & so forth. In case judicial officer at Serial No. 3 mentioned in the above said tables is on leave or busy in the Administrative work or is not available due to any reason his/her work shall be looked after by judicial officer at Serial No. 1 mentioned in the said table and so on & so forth. In case none of the presiding officers of Evening court are not available for a particular day due to any reason whatsoever, the work of the Evening courts shall be looked after by the duty M.M of that particular day.

**4.** Sh. G.K Mathur, Incharge Evening Court Cell, N-W District, Rohini court and three Ahlmads of Evening Court No. 1, 2 and 3 would be performing duty in addition to the duties already assigned to them from 5.00 PM to 7.00 PM and they will be entitled for evening court allowances as per rules.


