The Committee has initiated the scrutiny of the Declaration Forms. However the progress has been put to a halt for a number of reasons which are creating teething problems:-

1) The list of eligible voters of Delhi High Court Bar Association and Delhi Bar Association are in scanned form and not as computer generated output. Therefore, each and every form is to be manually cross-checked. The aggregated Declarations Forms

these two Bar Associations are more that 6,000/- which are to be cross checked against more than 3500. Thus total checks would 2,10,00,000 making the task immense. Had the list been provided in Excel Format as a computer generated output this problem would not have been confronted.

- 2) The Declaration Forms sent by Rohini Court Bar Association are place in various filed in a haphazard manner and not in a serial wise fashion. It is also consuming lot of time in the scrutiny of forms.
- 3) Despite various letters written to the authorities, we have received election record only pertaining to Delhi High Court Bar Association and Delhi Bar Association. No record has been received vis-à-vis the elections of any other Bar Association. We have learnt that KKD Bar Association is also in the process of scrutiny of its declarations.
- 4) Despite our repeated oral and written requests, Rohini Court Bar Association has not provided us any infrastructure support.

All these factors are impeding the pace of scrutiny of forms.

Let a letter be written to Rohini Court Bar Association on these aspects for compliance by tomorrow i.e. 07<sup>th</sup> March, 2017.
