1. The judicial officers shall be under the control of the District & Sessions Judges of the District to which they have been allocated.
2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause

list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

3. The Courts of MM-10 and MM-11, Central, THC (earlier presided over by Mr. Sunil Gupta and Ms. Chhavi Kapoor respectively) and MM-12, Central, THC (hitherto presided over by Ms. Prigya Gupta) are abolished. The District & Sessions Judge, Central, THC shall distribute the cases pending in their courts to other such Courts dealing with civil cases in the said District to ensure equal pendency.
5. The Courts of MM-9 and MM-10, West, THC (hitherto presided over by Mr. Abhinav Pandey and Mr. Puneet Nagpal respectively) are abolished. The District & Sessions Judge, West shall assign the cases of PS Nangloi to MM-4, West, THC; the cases of PS Hari Nagar and PS Madipur to MM-6, West, THC; and the cases of PS Paschim Vihar to MM-7, West, THC.
6. The Courts of Civil Judge-04 and Civil Judge-05, West, THC (hitherto presided over by Ms. Gita and Mr. Pranav Joshi respectively) are abolished. The District & Sessions Judge, West shall distribute the cases pending in their courts to other such courts dealing with civil cases in the said District to ensure equal pendency.
7. The Courts of MM-8, New Delhi, PHC (hitherto presided over by Mr. Manoj Kumar) and MM-9, New Delhi, PHC (earlier presided over by Ms. Niti Phutela) are abolished. The District & Sessions Judge, New Delhi shall assign the cases of PS Vasant Kunj (South), and the cases of PS R.K. Puram to ACMM-2, New Delhi, PHC; and the cases of PS Delhi Cantt., PS Naraina and PS Kishangarh to MM-2, New Delhi, PHC.
8. The Courts of MM-5, South, Saket (hitherto presided over by Mr. Vaibhav Mehta) and MM-6, South, Saket (earlier presided over by Ms. Vijeta Singh Rawat) are abolished. The District & Sessions Judge, South, Saket shall assign the cases of PS Mehrauli to ACMM, South, Saket; the cases of PS Hauz Khas to MM-2, South, Saket; and the cases of PS Safdarjung Enclave to MM-3, South, Saket.
9. The Courts of MM (Mahila Court)-4, South-East, Saket (hitherto presided over by Ms. Manika) and MM (NI Act)-5, South-East (earlier presided over by Mr. Ashok Kumar) are abolished. The District & Sessions Judge, South-East, Saket shall distribute the cases pending in their Courts to other such courts dealing with such cases in the said District to ensure equal pendency.
10. The Court of MM-4, North-East, KKD (hitherto presided over by Mr. Rakesh Kumar Rampuri) is abolished. The District & Sessions Judge, North-East, KKD shall assign the cases of PS Bhajanpura to MM-1, North-East, KKD; and the cases of PS Dayalpur and PS Shastri Park Metro to ACMM, North-East, KKD.
11. The Court of MM-8 North, Rohini (hitherto presided over by Ms. Richa Sharma) is abolished. The District & Sessions Judge, North, Rohini shall assign the cases of PS Bhalasva Dairy to MM-1, North, Rohini; and the cases of PS KN Katju Marg to MM-3, North, Rohini.


