**Agenda:- To consider the follow up of the meeting dated 21.08.2019 in respect of the amendment in the constitution of RCBA and list of members.**

**MINUTES**

This follow up meeting has been called in continuation of meeting dated 21.08.2019 of the Election Meeting wherein the directions contained in the order dated 19.08.2019 in writ petition (civil) No.8106/2010 titled P.K.Dash Adv. Vs. Bar council of Delhi & Ors. have been discussed. On the last date, the committee has desired to examine the amendment in the RCBA constitution and also called upon the Honorary Secretary RCBA to submit a list of members of RCBA within 3 days.

A down loaded copy of the order dated 19.08.2019 has been placed before the committee today. Matter discussed. On careful discussion, it has been resolved that the Hon'ble High Court vide aforesaid order dated 19.08.2019 directed the announcement of election and appointment of Returning Officer within 2 weeks. The reference to finalization of voter list was specific to the election of Tis Hazari Court complex. However, committee resolved that since the election process has to commence forthwith, it would be appropriate to continue with the process of finalization of list of voters for RCBA election 2019.

The committee has also received a letter 27.08.2019 from Honorary Secretary RCBA annexing the copy of amended RCBA Constitution and a request for one day time for sending the member's directory for consideration of the committee on the ground that the same could not be prepared till today.

The committee has duly considered the amended constitution of RCBA amended by GBM of RCBA on 07.09.2018 and duly countersigned by officer of the Registrar of Society on 14.06.2019. In so far as this committee is concerned, the amendment is in respect of inclusion of one post of Addl. Secretary and change in eligibility requirement of the candidate. The change is noted by the committee.
