Subject : Directions in respect of monthly statement.

It is observed that some of the Judicial Officers of North & North-West District, Rohini Courts, Delhi are not sending their Monthly statement well in time to this Office resulting in considerable delay in compilation and submission of the information to the O/o Ld. District & Sessions Judge(HQs) for its onward transmission to the Hon'ble High Court of Delhi.

As per the directions of the Hon'ble High Court of Delhi, Monthly statement of the concerned district has to be submitted to the O/o Ld. District & Sessions Judge(HQs) by 3.00 P.M. on 1st day of every month. Therefore, all the Judicial Officers of North District & North-West District, Rohini Courts, Delhi are requested to send the Monthly statement to the concerned Judicial Branch positively by 11.00 A.M. on 1st day of each month so as to enable this office to furnish the compiled data to the O/o Ld. District & Sessions Judge(HQs) for its onward transmission to the Hon'ble High Court of Delhi.

It has also brought to the knowledge of undersigned(s) that officials of concerned Judicial Branch have to visit the Courts personally for reminding submission of Monthly statement and frequently ask the Ahlmads to send the same. Henceforth, no further communication shall be done by this office and if Monthly statement is not received within the stipulated time, the data of concerned District will be sent to the O/o Ld. District & Sessions Judge(HQs) with a note regarding the Court which has not submitted its statement.

It be treated as most urgent and strict directions be issued to the Ahlmad by each officer.
