## Notes :-

- In modification of all the earlier orders of this Court on the subject, the Courts of ASJ-03 in all the Districts shall deal with the cases of TADA/POTA/MCOCA of their respective jurisdictions.
- The concerned District & Sessions Judge shall withdraw all cases other than cases relating to trial of offences against children, violation of child rights, cases under the POCSO Act, criminal appeals and criminal revisions from the courts of ASJ-01 in the respective District and assign the same to the courts of competent jurisdiction at the same location. The District & Sessions Judge shall also ensure that the Courts of ASJ-01 shall deal exclusively with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act.
- 3. The Court of ASJ-03, Shahdara, Karkardooma shall deal with the cases under the NDPS Act. The District & Sessions Judge, Shahdara, Karkardooma shall withdraw the cases under the NDPS Act pending in the Court of ASJ-1, presided over by Mr. Gurdeep Singh, and assign the same to the court of ASJ-3, Shahdara, Karkardooma, presided over by Ms. Savitri.
- 4. The District & Sessions Judge shall ensure equal distribution of cases in all the Courts. If any PC Act Court or the Court of ASJ-01 is not having sufficient number of cases, the District and Sessions Judge shall assign Criminal Revisions and Criminal Appeals to the said Courts.

- The court of ADJ-15, Central, THC hitherto presided over by Ms. Vandana Chauhan is abolished and the District & Sessions Judge (HQ), THC shall assign the cases of her court amongst other such courts so as to ensure equal pendency.
- The court of ADJ-6, South-West, Dwarka hitherto presided over by Mr. Vijay Shanker is abolished and the District & Sessions Judge, South-West, Dwarka shall assign the cases of his court amongst other such courts so as to ensure equal pendency.
