All the Officials on the strength of Office of Administrative Civil Judge (Central), Delhi, are hereby asked to exercise their option in terms of Rule 6(2) of Central Civil Services (revised Pay rules), 2016 in the prescribed proforma (copy enclosed) and submit the same in Room No. 111, Accounts Branch, Central District, Tis Hazari Courts, Delhi through, R & I Branch on or before 13/09/2016 (positively). The option once exercised will be final. In case of non receipt of option form, the Government Servant shall be paid revised pay structure w.e.f. 01.01.2016 till submission of option form or expiry of three months as per notification / adoption of CCS (RP), Rules 2016, and after that no request of change in option will be entertained /accepted. Officials are also requested to submit an undertaking in the prescribed proforma (copy enclosed) and undertake that in the event of their pay having been fixed in a manner contrary to the provisions contained in these rules, if detected subsequently, any excess payment so made shall be refunded by them to the Government either by adjustment against future payments due to them or otherwise. In all Options other than 1st January, 2016 they shall be ready to FOREGO ARREARS for the period from 1st January to the date they select to revise their pay.
