In continuation of earlier Circulars No. 1439/44137-297/Rectt.Cell/Selec.P.S./2017 dated 05.07.2017 and 2442/71359-559/Rectt.Cell/Selec.P.S./2017 dated 06.11.2017, applications are again invited from the eligible officials working on the posts of Head Jamadar/Daftari, Book Binder/Peon, Orderly, Dak Peon, Farash, Farash-cum-Dak Messenger, Chowkidar, Maali, Sweeper, Safai Karamchani in the Establishment of District & Sessions Judge (HQs), Delhi for filling up of vacant posts of Process Server (Group-C Non Gazetted) in PB- I, Pay Band of Rs. 5200-20,200/- with Grade Pay of Rs. 2400/- on regular basis.

Application in the prescribed enclosed proforma must reach this office latest by 13.08.2018 upto 5:00 P.M. No application will be entertained thereafter. The Officials who had earlier applied in response to this office earlier Circulars No. 1439/44137-297/Rectt.Cell/Selec.P.S./2017 dated 05.07.2017 and 2442/71359-559/Rectt.Cell/Selec.P.S./2017 dated 06.11.2017 are not required to apply afresh.

Criteria for the post of Process Server :-

- For Head Jamadar/Daftari : Matriculation pass or equivalent from a recognized Board having valid LMV Driving License (for the last two years).
- For Book Binder/ Peon/ Orderly/ Dak Peon/ Farash/ Farash-cum Dak Messenger/ Chaukidar/ Maali/ Sweeper/ Safai Karmchani : Matriculation pass or equivalent from a recognized board with five years service in the establishment of District & Sessions Judge (HQs), Delhi & having valid LMV Driving License (for the last two years).

The Mode of Selection:-

It would be an objective type test based on written examination followed by Driving Test and Interview. The question paper will comprise of multiple choice questions of 100 marks. Each question will carry 1 (one) mark and there will be 01 mark for each correct answer. There shall not be any negative marking. The Question paper will have 4 sections mentioned in below drawn table.
