**C I R C U L A R**

Vide the earlier circular issued by The Ld. District & Sessions Judge (HQs), Delhi bearing no. 37612-37782/Admn.I/Misc./2016 dated 24.11.2016 and this office circular bearing no. Misc./Admn./2016/33046-33116 dated 30.11.2016, the staff members were directed to strictly adhere to the formal uniform/dress code, as specified hereunder and also to display their Identity Cards in a manner so that they are clearly visible during the office hours:

For male staff members : Formal Shirt & Trouser with formal shoes  
For female staff members : Salwar Kameez with Dupatta (including churidar)  
Or  
Saree  
Or  
Formal Shirt and Trousers

It has been observed that the Staff posted in North-West District, Rohini Courts, Delhi is not complying with the directions issued vide above orders which is adversely affecting the working atmosphere and dignity of District Court Complexes.

Henceforth, the staff of North-West District, Rohini Courts, Delhi is directed to strictly adhere to the formal uniform/dress code as mentioned above and also to display their Identity Cards in a manner so that they are clearly visible during office hours. Any violation to this direction shall be viewed seriously.

**Note:- Non-compliance of order shall be viewed seriously and strict disciplinary action shall be initiated against the official concerned as per rules.**
