In continuation of this Court's notice published in various newspapers, on the website and elsewhere on 28.12.2019 whereby 19 vacancies [16 existing vacancies and 03 anticipated vacancies] have been advertised for Delhi Higher Judicial Service Examination-2019, it is hereby notified that the category wise bifurcation of 19 vacancies for Delhi Higher Judicial Service Examination – 2019 shall now be read as under:

**Note:**

Since there is no vacancy reserved for ST category in the current recruitment process as per the aforesaid revised category wise bifurcation of vacancies, therefore, the candidates belonging to ST category would not be entitled for any relaxation in marks on account of being an ST candidate. However, such candidates belonging to ST category would be eligible to compete against the General vacancies and would be governed by the criteria applicable to the candidates of General Category, in order to be shortlisted for the next stage of the examination.
