Whereas, the Central Government vide Ministry of Consumer Affairs, Food and Public Distribution Department of Consumer Affairs, Notification No. S.O. 3543(E) dated the 29th November, 2013 has issued the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Secondary) Amendment) Order, 2013:

And whereas sub-clause (1) and (2) of clause 1, and clause 2 of the aforesaid Order provides as belo

- "1.(1). This Order may be called the Removal of (Licensing requirements, Stock limits Movement Restrictions) on specified Poodstuffs (Second Amendment) Order, 2013.
 - It shall come into force on the 1st day of December, 2013.
- In the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, in clause 7, in sub-clause (1), for item (ill), the following item shall be substituted, namely:-
 - "(iii) paddy and rice for a period up to 30th November, 2014"."

Governor of National Capital Territory of Delhi, in exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the order issued by the Government of India, Ministry of Agriculture (Department of Food) Notification No.G.S.R.800 dated the 9th June, 1978, hereby orders that Order No.F.3(4)/2002/F8.8/P6C/(3)/17 dated the 20th June, 2002 relating to the Delhi Foodorsine and Chiesede Delhes I location Power (1988, abelli to be best to be extracted. Delhi Foodgrains and Oilseeds Dealers Licensing Order, 1988, shall be kept in abeyance, to the extent of the provisions of the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Second Amendment) Order 2013, dated 29th November, 2013 for a further period up to 30th November, 2014 in respect of paddy and rice.
