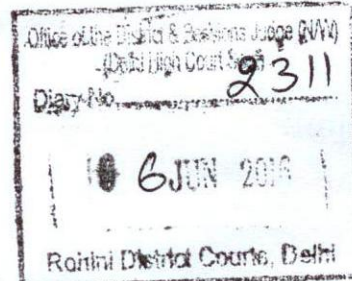

Learned counsel for the Delhi High Court has produced before us a copy of the minutes dated 30.04.2016. Let the same be kept on record. The said committee has examined the report submitted by the District & Sessions Judge (HQ). In view of the said decision and reasons recorded, the direction for recording of statements through Civil Judges as local commissioner will be discontinued.

There is concern about lack of infrastructure for functioning of Family Courts. The Delhi High Court has filed before us a copy of application moved in CM(M) No. 08/2015, Puneet Gupta versus Ruchika Gupta. Paragraph 7 & 8 of the application read as under:



"7. In regard to the status of the Family Courts, it is submitted that at present there are 15 Family Courts functioning in the 11 Districts of Delhi. Two each at South West District (Dwarka), North West District (Rohini), North District (Rohini) and West District (Tis Hazari Courts) and one each in the remaining seven Districts.

8. That the applicant in view of the pendency of the cases, has also requested to the Govt. of NCT of Delhi to take necessary steps for establishment of 6 additional family courts i.e. one each at Central and West Districts (in Tis Hazari Courts Complex), one at South East District (in Saket Courts Complex) and one each at Shahdara District, East District and North East District (in Karkardooma Courts Complex) however the approval of the Govt. of NCT of Delhi has not been received yet. A copy of the letter dated 26.09.2015 is annexed hereto and marked as Annexure A-1."

The Government of NCT of Delhi will file their response to the aforesaid averments within a period of three weeks from today with a copy to the counsel for the Delhi High Court. The response would indicate the steps taken and would be taken to deal with the emergent situation.
