Notes:

- 1. The Judicial Officers shall be under the control of the District & Sessions Judge of the District to which they have been allocated.
- 2. The new courts of ASJ-6 (POCSO), North, Rohini and ASJ-4 (POCSO), South, Saket are designated as the Children's Courts under the Commissions for Protection of Child Rights Act (CPCR Act) which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to ASJ-1 in the concerned District.

- The Courts of PO, Labour Court, Dwarka, being presided over by Ms. Mamta Tayal and Ms. Preeti Aggarwal Gupta shall stand abolished w.e.f. 22nd April, 2019 and the Court of PO, Labour Court, Dwarka being presided over by Mr. Rakesh Kumar-I, shall stand abolished w.e.f. 30.4.2019. The District & Sessions Judge, South-West, Dwarka shall take steps for assignment of the cases of these three Courts to other such courts so as to ensure equal pendency.
- 4. The District & Sessions Judges of North and South Districts, shall issue orders distributing the work relating to POCSO Act and CPCR Act amongst each such ASJ Court (where there is more than one such Court in the District) specifying the Police Stations for purposes of fresh cases registered or instituted henceforth to ensure equitable distribution, under intimation to this court.
- 5. The District & Sessions Judges, North and South Districts while making compliance with the directions in the preceding note, shall also withdraw sufficient number of existing cases bearing in mind the above from the Court of ASJ-01 (POCSO) and assign them to the newly created courts of ASJ (POCSO) in the District, to ensure equitable distribution.
- 6. The concerned District & Sessions Judge will ensure that proper track is kept about movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified on the website of District Courts as also outside the transferor court(s).
