1	To consider the Letter dated 22.10.2019 of the President and the Hony. Secretary, R.C.B.A. seeking extension of date of filing of Declaration Forms	<p>It is stated in the letter that huge number of Advocates could not submit their declaration forms as most of the time server was down as well as the printer was also not in proper condition due to heat and heavy workload. The same has been duly appended by many members of the RCBA.</p> <p>The Committee has considered the letter minutely and unanimously opined that in view of the reasons stated in the letter and the fact that maximum number of advocates should exercise their franchisee, the request is acceded to. Accordingly, the last date of accepting Declaration Forms is hereby extended upto 31.10.2019(till 5:00 pm).</p> <p>The RCBA is expected to give wide publicity of extension of last date for filing of Declaration Forms by pasting on Notice Board and posting of Social Media clearly mentioning that no such form shall be accepted after 5:00 pm on 31.10.2019.</p> <p>In view of the above extension, the Committee further unanimously resolved that the provisional list of Voters shall be displayed on 11.11.2019 and period of calling objections from 11.10.2019 to 18.10.2019. The Final List of eligible voters then shall be expected to be released by 30.11.2019.</p> <p>In the light of the above, it is expected that RCBA shall also carry out scrutiny exercise to minimise objections and to ensure that no bogus member/ Non-advocate can file Declaration Form. A scrutiny list be also furnished by the RCBA to the Election Committee by 31.10.2019.</p>


To fix a cut off date for exercising voting right in the election of RCBA in the light of Rule 6A of the Constitution of RCBA

The Committee has gone through Rule 6A of the constitution of the RCBA which reads as below:

"6A. VOTING RIGHT

No member shall have voting right in the election of RCBA if he has not completed minimum one year on the roll of the RCBA on the day when final voter list is issued by the Election Committee"

In the light of the above provision, the Committee is of the unanimous opinion that since the date of displaying/ uploading Final List of eligible Voters is expected to be



		30.11.2019, the cut off date, in the light of above provision, is hereby fixed as 30.11.2018 . The members enrolled on the Roll of the RCBA after 30.11.2018 will not be eligible to exercise voting right in the RCBA Election 2019.
3	To consider availability of sufficient number of staff and infrastructure	<p>The Committee has considered this aspect in the light of number of members of the RCBA which is around 7500. Since the nature of work of the RCBA Election comprised of many folds, the Ld. District & Sessions Judge (N-W) be requested to provide as below :</p> <p>a) separate space/ room having necessary infrastructure i.e., power plug, tables, chairs, internet connection etc.,</p> <p>b) four staff members preferably JJA/JA who are well versed with computer operation(excel) with effect from 01.11.2019 to 15.12.2019.</p> <p>c) four Computers along with accessories,</p> <p>d) Four 16 GB Pendrives</p>
4	Non- providing of list of Voters of RCBA despite repeated reminders	The office has informed that despite repeated requests the office of the RCBA has not provided refined list of members of the RCBA after removal of deficiencies. The Committee has expressed its displeasure. The Hony Secretary, RCBA is impressed upon to provide the requested list within 03 days ensuring that the list is complete in all respects so that verification can be carried out smoothly.
