- [ii] the Criminal Appeals and Criminal Revisions (other than those pertaining to PC Act) pending before the above courts shall not be transferred and will be dealt with in the District where they are pending, and will be assigned by the concerned District & Sessions Judges to the other Sessions Courts in the District ensuring equal distribution.
- [iii] the criminal appeals, criminal revisions pending in the court presided over by Shri Arun Bhardwaj, Special Judge [PC Act] [CBI], against the order[s] passed by the court of Shri Samar Vishal, ACMM, (exclusive court for dealing with cases of MPs/MLAs at Magisterial level), shall be dealt with by the court of Shri Arun Bhardwaj, Special Judge [PC Act] [CBI], Rouse Avenue Court Complex, being designated Court to exclusively deal with cases of MPs/MLAs.
- [iv] the records of cases under P.C. Act decided after 01.01.2015 by the above CBI/ACB Courts, yet to be consigned to Record Room[s], shall be consigned to Record Room at the Rouse Avenue Court Complex.
