KKD, ASJ-05 (POCSO) South, Saket and ASJ-09 (POCSO), West, THC are designated as the Children's Courts under the Commissions for Protection of Child Rights Act (CPCR Act) which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to other POCSO Courts in the concerned District.

3. The Court of ASJ-05, North, Rohini [henceforth ASJ-05 (POCSO), North, Rohini] presided over by Mr. Vinod Kumar is designated as the Children's Courts under the Commissions for Protection of Child Rights Act (CPCR Act) which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to other Courts of ASJ (POCSO) in the concerned District.
4. The Court of ASJ-04, North-West, Rohini [henceforth ASJ-04 (POCSO), North-West, Rohini] presided over by Ms. Raj Rani is designated as the Children's Courts under the Commissions for Protection of Child Rights Act (CPCR Act) which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to other Courts of ASJ (POCSO) in the concerned District.
5. The Court of ASJ-05, South-West, Dwarka [henceforth ASJ-05 (POCSO), South-West, Dwarka] presided over by Mr. Gurvinder Pal Singh is designated as the Children's Courts under the Commissions for Protection of Child Rights Act (CPCR Act) which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to other Courts of ASJ (POCSO) in the concerned District.
6. The Court of ASJ-06, South-East, Saket [henceforth ASJ-06 (POCSO), South-East, Saket] presided over by Ms. Neera Bharihoke is designated as the Children's Courts under the Commissions for Protection of Child Rights Act (CPCR Act) which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to other Courts of ASJ (POCSO) in the concerned District.
7. The District & Sessions Judges of North, North-West, South-West and South-East Districts shall withdraw the Sessions cases (other than under the CPCR Act and POCSO Act cases) from the Courts of ASJ-05, North, Rohini, ASJ-04, North-West, Rohini, ASJ-05, South-West, Dwarka and ASJ-06, South-East, Saket and allocate them to other Sessions Courts in their respective districts so as to ensure equal pendency.
8. The District & Sessions Judges shall issue orders distributing the work relating to POCSO Act and CPCR Act amongst each such ASJ (POCSO) Court (where there is more than one such Court in the District) specifying the Police Stations for purposes of fresh cases registered or instituted henceforth to ensure equitable distribution, under intimation to this Court.
9. The Court of ASJ-05, East, Karkardooma [henceforth ASJ-05-cum-ASJ(Electricity), East, Karkardooma] presided over by Mr. Surinder Kumar Sharma is henceforth additionally designated as ASJ (Electricity), East, Karkardooma.
10. The Court of ASJ-02, North-West, Rohini [henceforth ASJ-02-cum-Special Judge (NDPS), North-West, Rohini] presided over by Mr. Deepak Garg is additionally designated as Special Judge (NDPS), North-West, Rohini.
11. The Court of ASJ-04, New Delhi, PHC presided over by Mr. Anil Antil is designated as the Special Court under Section 74 of the Food Safety and Standards Act, 2006 in place of ASJ-01 (POSCO), New Delhi, PHC. The District & Sessions Judge, New Delhi shall withdraw the cases under the said Act from the Court of Ms. Ruby Alka Gupta, ASJ-01 (POCSO), New Delhi and assign the same to the Court of Mr. Anil Antil, ASJ-04, New Delhi, PHC.



12. The Court of ASJ (Pilot Court) in West District, THC presided over by Mr. Saurabh Pratap Singh Laler is redesignated as ASJ-08 West, THC.

✓ 13. The concerned District & Sessions Judge will ensure that proper track is kept about movement of cases from transferor court (s) to transferee court (s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified on the website of District Courts as also outside the transferor court(s).

✓ 14. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.




