## Notes:

- 1. The judicial officers shall be under the control of the District & Sessions Judge of the District to which they have been allocated.
- 2. The Judicial Officers under transfer shall pronounce the judgments/orders in the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the postings/transfers order, and in case any matter for pronouncement of judgment/order has been fixed beyond the effective date of postings/transfers order, then the said matter shall be preponed and the judgment/order shall be pronounced before relinquishing the charge of the court in terms of the postings/transfers order.
- 3. The concerned District & Sessions Judge will ensure that the proper track is kept about movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified on the website of District Courts as also outside the transferor court(s).
- 4. The concerned District & Sessions sudge will assign sufficient number of cases to the newly created courts as above on withdrawal from other courts of said District ensuring equal distribution except where the work is specifically assigned as above.
- The District & Sessions Judge, West, THC shall assign work arising out of investigation of cases of PS Mayapuri on withdrawal from the Court of MM-1, West, THC to the Court of Ms. Ritu Singh, MM-7, West, THC.
- The Court being presided over by Ms. Richa Manchanda, MM (Mahila Court), North, Rohini stands redesignated as MM (Mahila Court)-1, North, Rohini.
- 7. The eight judicial officers who are completing training in the Delhi Judicial Academy on 31.07.2017 shall be attached with the courts to which they have been posted or to courts exercising similar jurisdictions till then.
