The approval is further subject to the condition as contained at para 2 of Circular No. F. 21/201/GAD/CT/Tel/2967 dated 13.9,2013 issued by the General Administration Department, Govt, of NCT of Delhi that the mobile phone will not ordinarily be replaced within a period of two years from the date of its purchase. However, if at any point of time, the probable cost of repairs exceeds 50% of the total initial cost of the mobile instrument, such a replacement may be allowed.

Further, the earlier approval regarding the mobile phone facility to the rest of the Judicial Officers i.e. Civil Judges (entry level) (except those who are on training during their probation) conveyed vide this office letter No. F.1/80/05-Judi./Suptlaw/695-696 dated 12-09-2012, under which they were entitled to Rs. 10,000/- towards the cost of hand set and a monthly ceiling of Rs. 1500/-towards the rental and call charges, shall also remain in force.
