No. F 13(43)/09/Misc/DC/Enft/....- In supersession of notification No. F.21(60)/2001/h& w/sslhfw/5-14 Dated 26<sup>th</sup> Aug, 2010 issued in this regard, except as respects of things done or omitted to be done before such supersession and in exercise of the powers conferred by sub-section (1) of section 36AB of the Drugs and Cosmetics Act, 1940(23 of 1940), the Lt. Governor of the National Capital Territory of Delhi, in consultation with the Chief Justice of the High Court of Delhi, hereby designates the Court of Additional Sessions Judge-01, in each district of the National Capital Territory of Delhi, as Special Court for their respective Sessions Division for trial of offences relating to adulterated drugs or spurious drugs and punishable under clauses (a) and (b) of section 13, sub-section (3) of section 22, clauses (a) and (c) of section 27, section 28, section 28A, section 28B and clause (b) of sub-section (1) of section 30 and for other offences relating to adulterated drugs or spurious drugs and also for all other offences punishable under Chapter IV of the Drugs and Cosmetics Act, 1940 with immediate effect.

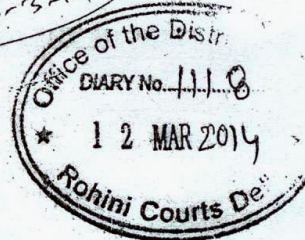
