
The Metropolitan Magistrates (Reliever) shall be assigned work of respective link duty, TIP, Inquest proceedings, recording statement under section 164 Crpc besides administrative duties as per Hon'ble High Court of Delhi Order No. 24/DHC/Gaz./G-7/VI.E.2(a)/2022 dated 24-08-22 as per above mentioned table.

It is clarified that only One statement U/s 164 Cr.P.C. for recording of statement shall be marked by the each court in a day to their Reliever MM. The other applications U/s 164 Cr.P.C. shall be disposed off by their concerned Link MM as per previous link roster.

2. All the TIP & Inquest applications shall be dealt by both the Reliever MM's as per their schedule. These two Reliever MM shall co-ordinate with each other regarding TIP of entire North-West District.

3. Ld. MM (Reliever) shall also ensure that the statements u/s 164 Cr.P.C. are recorded on the same day unless for compelling reason (duly recorded in the order sheet), adjournment becomes imperative.

4. Whenever any Link MM (Reliever) is on leave, the applications U/s 164 Cr.P.C. for recording of statement shall be dealt by the Link MM as per previous Duty Roster bearing no. 23351-23414/CMM/NW/Rohini/2022 dated 16-08-22.


