In case judicial officer at Serial No. 3 mentioned in the above said tables is on leave or busy in the Administrative work or is not available due to any reason his/her work shall be looked after by judicial officer at Serial No. 1 mentioned in the said table and so on & so forth. In case none of the presiding officers of Evening courts are not available for a particular day due to any reason whatsoever, the work of the Evening courts shall be looked after by the duty M.M of that particular day.
