
Sub: Declaration Forms for RCBA Elections - 2023.



- 3) The photograph should be original photograph of the member and not a computerized image, in which case, the form shall be summarily rejected.
- 4) The photograph should be signed by the member (preferably with the CD Marker/indelible ink) in such a manner that half of the signature comes on the form and the other half of the photograph itself.
- 5) Please attach a copy of ID card of RCBA/BCD or any other Bar Association.
