# CORAM: HON'BLE MR. JUSTICE JASMEET SINGH ORDER 26.05.2023

- On 05.04.2023, it was recorded that the efforts of stakeholders are in the right direction and the files are being processed and the process of compensation is being initiated.
- Ms. Kaur, learned counsel appearing for the Bachpon Bachao Andolan (BBA) states that there are severe bottlenecks faced in the process. She states that the files are not being made available to the Lawyers for conducting inspection.
- On 12.12.2022, this Court had directed as under:-

"6. With a view to pre-empt the difficulties likely to be faced quatifile inspection by the proposed team of lawyers of BBA, I deem it fit to direct the Ld. Principal District and Sessions Judges to direct the concerned Judges/ Ahlmads / Record Room In-charge to identify and trace out the files of the disposed of POCSO

cases/ Rape cases/ other sexual offence cases expeditiously and to permit inspection by the Lawyers provided by BBA (in whose favour DSLSA issues entrustment/ authorization letter), so that the records can be inspected and appropriate applications for compensation can be filed at the earliest. Needless to say that these lawyers shall be sensitized with regard to maintaining the confidentiality and respect for privacy of the victim while inspecting records and making reports as proposed."

- 4. Despite these directions, the concerned Ahlmads! Record Room In-Charge are taking their own sweet time to make the files available to the lawyers and the rights of child victims are getting severely affected due to the same.
- The learned Principal and District Sessions Judges are directed to identify the Ahlmads and Record Room In-Charge who are not complying with the order dated 12.12.2022, fix responsibility upon them and take disciplinary action against them.
- The report be filed before the next date of hearing.
- In addition, the addresses of the child victims to whom the compensation is to be paid are not being made available.
- 8. As per the SOP, the I.O. concerned has to contact the child victim and thereafter share the details with Rape Crisis Cell (RCC) Lawyer to move the application for compensation.
- The order will be communicated to the DCP, Legal Cell to ensure immediate compliance.
- 10. The Secretary (Litigation), DSLSA who is present through video

conferencing mode shall also ensure that necessary steps are taken in this regard.

11. It is brought to my notice that the Lawyers at BBA are available during

the entire summer holidays.

12. This order be sent to respected District Judges so that files are made available for inspection. The stakeholders are at liberty to file an application for appropriate orders.
