

Respected Sir,

This is with reference to receiving of proposals to this Department from the Director (Prosecution), Delhi to file appeal in cases where Orders on Sentence of Ld. Trial Courts are silent on grant of expenses to the State for conducting the prosecution.

In one such case titled as State Vs Mahesh, FIR No. 539/2014, P.S. Mehrauli, the following direction has been received from the office of Hon'ble Lt. Governor:

"vide para no. 180 of the judgment titled as 'Karan vs. State' a mechanism has already been established by Hon'ble High Court and all the Trial Courts are already sending list of cases decided each months to Registrar General of Hon'ble High Court with requisite details for put up it before the ACR committee of Judicial Officer. Hon'ble Lt. Governor has desired that instead of filing appeal for non-compliance of directions of Hon'ble High Court in case titled Karan vs. State, the information of non-compliance may be forwarded to Registrar General, Delhi High Court for consideration and appropriate action on administrative side of Delhi High Court."

In compliance with the above directions of Hon'ble Lt. Governor, the information of such cases (for the period 01.01.2023 to 30.04.2023) as submitted by Directorate of Prosecution, Delhi is being forwarded herein for information and necessary action, as deem fit and proper, in the matter.

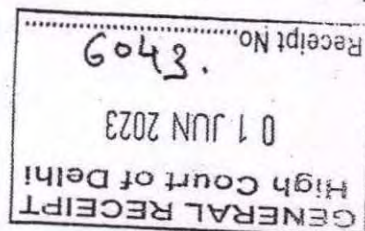
