CIRCULAR

In terms of the directions contained in circular no. 30314-30439/IT Cell/2023 dated 16th August 2023 issued by the Ld. Chairman (I.T. & Digitization)/ Centralized Computer Committee, Tis Hazari Courts, Delhi, all the Judicial Officers posted within the domain of North-West district are requested to direct the concerned staff to contact Digitization Branch, Rohini Courts for sending the scanned/digitized Trial Court Record of pending/un-consigned decided cases/files to Hon'ble High Court of Delhi. In case of consigned decided files, the scanned/digitized Trial Court Record shall be sent/uploaded/transmitted by the Incharge, Record Room, Rohini Courts.

The officials posted in the Digitization Branch and Record Room are impressed upon to send/transmit the scanned/digitized Trial Court Record to Hon'ble High Court of Delhi immediately/atleast 2 days in advance as and when requisitioned by the Hon'ble High Court of Delhi through URL https://164.100.43.212/sslvpn/Login/Login enabling the IT Cell of Hon'ble High Court of Delhi for taking the further necessary action at their end.
