

In continuation of previous e-mail dated 13.09.2023, wherein it was requested to your good self to seek willingness from the Judicial Officers posted at your District as well as the advocates practicing in your Districts (preferably having at least 3 years standing at bar), through respective Bar Associations for constituting a panel of translators consisting of retired Judicial Officers, Judicial Officers of District courts, retd. Translators and advocates practicing at District Courts so that Judgments of the Hon'ble Supreme Court which are uploaded on e-SCR portal may be assigned to them for the purpose of vetting.

Since, a large number of Judgments available on e-SCR portal are to be translated within a stipulated time frame and also fresh Judgments are being sent by the Hon'ble Supreme Court for vetting on regular basis, more number of retired Judicial Officers and Advocates are required to maximize the strength of existing pool of translators.

Therefore, I may request your good self to seek willingness from the Judicial Officers posted at your district, Retired judicial officers as well as from the Advocates practicing at your district (preferable having 3 years standing at bar), for the work of vetting the translated Hon'ble Supreme Court Judgments and send the list of such Officers as well as advocates latest by 04:00 p.m. on 27.09.2023, for further communication to the Hon'ble Supreme Court. It is also pertinent to mention that those who had previously given their willingness for the vetting of judgments are not required to give their willingness again as they are already in the list of pool of translators.
