

**NOTIFICATION ON E-FILING OF CASES**

It is for the information of all Lawyers and General Public that a new version of e-Filing software i.e. e-Filing 3.0 shall be made operational at Delhi District Courts w.e.f. 01.11.2023 on a new URL: <https://filing.ecourts.gov.in>

The current e-Filing services at URL: <https://efiling-dl.ecourts.gov.in> shall be shut down w.e.f. 24.10.2023 midnight for the purpose of migration to a newer version i.e. e-Filing 3.0. The e-Filing will resume at a new URL: <https://filing.ecourts.gov.in> on 01.11.2023 at 11:00 AM, thus it is advised to all the stakeholders to clear all pendency lying as **Draft/Defective** in the Dashboard of existing e-Filing portal and submit the same well before 24.10.2023 as such cases shall not be migrated to e-Filing 3.0.

During 25.10.2023 to 31.10.2023, in terms of "eFiling Rules of the High Court of Delhi 2021", all filings will be done physically at the respective Filing Counters of the concerned districts at all Delhi District Courts. However, if due to any technical or circumstantial glitch, the e-Filing 3.0 is not made operational on 01.11.2023, the same shall be notified separately.


